



### ADA (HANDICAP) PARKING

Team,

There have been a lot of questions regarding ADA parking in the parking lots. I would like to take a moment to clear up some questions.

In all parking lots, an individual with an ADA parking placard displayed either on the rear view mirror, dash or those who have an ADA license plate, may park in the posted ADA parking spaces with any make/model vehicle (this includes foreign vehicles) as per the Americans with Disabilities Act.

In parking lot 1, the ADA parking spaces that are located along the plant 1 wall west of the turnstiles, are no longer ADA spaces. The ADA parking spaces for lot 1 are those located south of the smoke shack in lot 1. The signs that are on the plant wall west of the turnstiles will be removed when manpower and weather permits.

# Hourly Employee Profit Sharing - Deferral Election Window Announced

In the event that there is a payout under the Profit Sharing Plan, you will have the opportunity to contribute all or a portion of your payout in one percent increments, up to 100 percent, or a flat dollar amount, to your Personal Savings Plan (PSP) on a pre-tax basis, subject to tax law limitations. Deferral contribution elections will be accepted between 8:00 a.m. EST on January 26, 2018 and 4 p.m. EST on February 9, 2018. Elections can be made online at gmbenefits.com or by calling the GM Benefits & Services Center at 1-800-489-4646.

If you are considering deferring all or a portion of your Profit Sharing payout into your PSP account, please consider the following:

- $\hfill \square$  You must make a new deferral election during the window period.
- $\ \square$  The payout will be subject to FICA taxes and Union dues.
- □ For active employees receiving wages, your Profit Sharing contribution will be the percentage or flat dollar amount you elect, provided your other wages are enough to satisfy the FICA and Union dues obligations on the combined wages and Profit Sharing payout.
- □ For active employees not receiving wages, your Profit Sharing contribution will be after FICA taxes and Union dues are deducted from the Profit Sharing payout.
- ☐ Any outstanding payroll or benefit overpayments, special court orders for child support arrearages, tax levies or similar obligations will be deducted from your Profit Sharing payout before any contributions are made to the PSP.
- ☐ You must be eligible to accumulate savings in the PSP for your contribution election to be effective.

# **General Motors Teen Driver Software**

"We Are GM"



With the CDC reporting motor vehicle crashes as the leading cause of death for teens, a group of engineers from multiple disciplines decided to make a difference in

the lives of our customers by helping to inform parents about driving habits of their teens.

MaryAnn Beebe, an engineering specialist who has spent her career at General Motors working on technologies related to safety, helped to lead the initiative.

"This project, like many others that I'm involved in, touched me personally," she said. "As a mother of small children, I know that anything with the potential to keep your family safe is always on a parent's mind."

Working together, the group created Teen Driver, a newly developed software with a simple interface that allows parents to monitor their teen's driving habits while not in the vehicle. This technology provides parents with the information needed in order to discuss and reinforce safer driving habits with their young drivers.

Following its introduction on the 2016 Chevrolet Malibu, the technology has been rolled out across the GM brands and nameplates. Parents have praised the feature, saying it gives them peace of mind. And media covering the technology have carried the message of how it helps parents while bringing attention to a very important driver safety issue.

"To know that someone's life was saved or changed for the better by something you had a hand in creating, that's a reward incapable of being measured," Beebe said.

#### Two Semis Crush Man's Pickup



On January 17, 2015, there was a 26 car pile up on Interstate 84 near Baker City, Oregan. Black ice and heavy fog were the contributing factors.

This photo of Kaleb Whitby's barely visible Chevy Silverado pickup was crushed between 2 semi-trucks in that incident.

Kaleb hit the trailor of an out of control semi-truck that was coming at him. Seconds later another semi, unable to stop, slammed into his Silverado pick-up. The semi drivers, and first responders assumed there were no survivors, but instead he walked away with only 2 small cuts on his hands.

#### Preventing the Flu



Since Christmas influenza illness has really spiked in Ohio. Recently local hospitals have been at full capacity, with flu being a significant contributor to illness.

And several deaths have been reported across all age groups.

Though there have been reports that the flu vaccine is only 10% effective, that is the case for only 1 of the virus subtypes which were included in the vaccine for this year. And, while the effectiveness of the vaccine for preventing that type of flu, it can still help reduce the severity of influenza illness if you get ill from it. It is not too late to get the vaccine. Medical still has a limited supply of vaccine; just come and get it!

There are other practices which can help to reduce your chances of contracting the flu. The virus is spread two ways: through airborne droplets, and by transferring the virus from any surface to your hands, then to your face, nose or eyes. So:

- Avoid close contact with persons who are ill.
   Ask them to cover their mouth when they cough—with their sleeve, or with a disposable tissue.
- Avoid shaking hands—a lot of virus can be on a person's hand, even if they are not themselves ill.
- If you share radios, phones, desks, pens, etc. with other people, wipe the surface down with a chlorine or alcohol wipe prior to your use.
- Wash your hands often with hot water and soap, or use hand sanitizer.
- Get out of the habit of touching your face, eyes or nose. That is how the virus is transferred from the hand to the face where it will infect the nose and upper respiratory tract.

If you become ill with flu symptoms (cough, runny nose, high fever, muscle aches), stay home and avoid others. Return to work and other outside activities only after the fever has been gone for 24 hours. If you are at high risk for complications (those with diabetes, chronic lung conditions, compromised immune system, chronic kidney disease) then an antiviral medication may help. These are most effective when started within 1-2 days of becoming ill. Talk to your doctor about it.



Walking and Working Surfaces, Personal Protective Equipment and Workplace Safety Rules, Noise, Fire and Explosion Control and Respiratory Protection. May add Safety Design and Launch. Are there any issues with the list? Al said he can look at Cranes, Hoists and Associated Equipment. *HRIAC Team Update:* Mark reviewed the Hazard & Risk Identification.
